In consideration of being permitted to participate in the activities described above of the 1st OVI, I agree to assume ANY AND ALL RISKS OF INJURY OR **DEATH** which might be associated with or result from my participation in 1st OVI events. **INITIAL HERE**

I further release, waive, discharge and covenant not to sue the 1st OVI, the organizers of any 1st OVI event, the trustees of, officers of, agents of, employees of, or members of the 1st OVI, or the owner or lessor of any property on which the 1st OVI conducts any activity; from all liability to myself or any other party claiming an interest through myself, for all loss or damage or demand thereof on account of injury to the person or property, or death of myself, whether caused by their NEGLIGENCE or for any other reason, while preparing for, traveling to, or from participating in any 1st OVI event.
